Effective 19 January 2010, the following members are recognized for their participation in AFRCC Mission 10M0046. This mission involved a search for a missing Cessna 172, N13073, while on a training flight from Roy Williams Airport to Palm Springs, CA. CAP aircrews and ground teams located the wreckage in a remote part of Joshua Tree National Park. A ground team comprised of CAP, National Park Service, and Riverside and San Bernardino County Sheriff SAR personnel hiked cross-country to locate the aircraft and extricate the injured occupants, who were transported to the hospital. Two SAVE Awards were authorized for CAWG by AFRCC.
